Declaration of consent

I give WVV permission to process data about me:

1. Processing of my personal data, contact details and other information provided by me. WVV adds there data of membership and for league-playing members competition-related Nevobo data.

(Note: Registering this type of data is a logical consequence of membership in a sports association. Not only to be able to WVV an adequate membership file with the application of a correct correspondence, but also to be able to meet legally regulated information requests from official bodies such as police and tax authorities, the Need to have the right data.)

2. Sharing my data with the Nevobo as necessary to be able to play league matches.

(Note: WVV is a member of the Nevobo. The forwarding of personal data is carried out in the context of the – Compulsory – Registration with the Nevobo to be active in the Nevobo-competition as league player, referee, trainer, Orange ambassador and/or board member.)

3. Send to me, by e-mail, of: the contribution note the newsletter, the competition program, invitations to attend meetings, invitations for association activities, activities in the field of volleyball by other sports associations or the Nevobo. Also to approach me in the context of "love and sorrow".

(Note: WVV regularly sends so-called newsletters. It lists news facts, proclaims and special features within WVV. With the sending of these letters, we hope not only to involve the members in the association, but also to send information that is useful.

All WVV-members become informed about the competition program with all its modified versions of the current season where the WVV competition players participate. It also identifies when and who is acting as a referee or counter.)

4. Publishing by or on behalf of WVV during competition Competitions and association activities made reports and photos of me on the Internet, social media, the local newspapers, WVV Pr material and the WVV Publishing Board. *Note: The PR Committee ensures that no negative aspects are shown about people.*

(Note: By or on behalf of WVV, photos are taken during competitions and tournaments. In order to have the full recruitment benefit of the PR documents, this is accompanied by a copy for publication to the aforementioned media, also for publicity reasons. Internal announcements such as the Competition program, the newsletter and invitations do not appear in the daily or weekly newspapers.)

5. Recording photos to which I am identifiable: on the website, Facebook or WVV Public Relation folders.

(Note: On behalf of the board, it is the PR Committee and the competition secretary who made the pictures and copies mentioned here. Sometimes out of necessity – such as the Contest Program – but also especially to make the copy, the story lively, informative and recruiting.)

6. By WVV archiving my callsign, last name, date of birth, membership and contact information after I have cancelled my membership, to be able to invite me to future special activities.

(Note: WVV finds it particularly enjoyable if, when celebrating a special event or anniversary, it has the opportunity to invite its former members too. Hence the question of whether WVV can approach you.)

7. For the purpose of association history in the old archive of WVV, include photos *, reports *, leaflets * and other material on which my name is listed or my image appears.

(Note: Since its inception in 1962, WVV has created an archive in which all historically important data are kept. Below are members lists, club magazines, photographs as well as reports of administrative and ALV meetings. This historical archive is in principle only accessible to board members and is stored in a closed steel filing cabinet.)

I know that the old archive is kept separate from the daily correspondence in a closed steel cabinet and that without this permission is not shared with third parties.

My permission applies only to the above-mentioned and not retrieved data. For a new processing of (new) data, WVV asks in a General Members Meeting permission.

I always have the right to view, modify or have my data deleted. I may withdraw my consent at any time.
